#### WISCONSIN STATE UNEMPLOYMENT RATE DROPS TO 7.3 PERCENT

# U.S Bureau of Labor Statistics corrects overestimate of Wisconsin's October job loss numbers to 2,400 from 9,700

MADISON – Department of Workforce Development (DWD) today released the Bureau of Labor Statistics (BLS) monthly report showing Wisconsin's unemployment rate dropped to 7.3 percent from 7.7 percent. October's job loss number was significantly reduced to 2,400 from the initial estimate of 9,700, a 75 percent correction.

Secretary Reggie Newson today issued a statement on the newest set of monthly Wisconsin employment numbers.

"October was the fifth straight month and the eighth month this year in which the federal government overestimated the preliminary job loss numbers or underestimated job gains for Wisconsin," Secretary Newson said. "I am particularly concerned by the disparity in the October preliminary numbers, which were off by 7,300 for total jobs and 7,900 for private-sector jobs. These unreliable employment statistics out of Washington misinform the public and create unnecessary anxiety for job seekers and job creators about the shape of our state's economy."

According to the U.S. Bureau of Labor Statistics (BLS), Wisconsin's revised numbers show the state lost 2,400 jobs in October, roughly a 75 percent correction from their initial estimate of 9,700 jobs. Meanwhile, Wisconsin added 11,000 jobs in June, but BLS initially underestimated that number by roughly 1,500 jobs.

"The most troubling thing to me is the effects these initial estimates have on the perception of Wisconsin's workforce," continued Secretary Newson. "The monthly revisions show a much steadier trajectory with gains being higher and losses being much lower than the BLS' initial reports. While there certainly is more progress to be made, we are moving Wisconsin in the right direction and laying the groundwork for the private sector to create jobs."

Since January 2011, the revisions between the state's preliminary job loss numbers and the revised numbers have varied wildly:

Under an ongoing annual contract between the state and BLS, the monthly employment estimates are generated from a survey of approximately 4 percent of Wisconsin employers. The survey data are transmitted to Washington, where BLS generates the preliminary estimates and sends the numbers to Wisconsin to publish. The BLS revises the estimates as additional data comes in, but the revisions aren't published until the following month. The BLS' November preliminary estimates for Wisconsin indicate a decrease in total jobs by 14,600 on a seasonally adjusted basis.

"We are required by the federal government to release its preliminary numbers on a monthly basis, even though the numbers can be off by as many as 9,400 jobs and still be considered by BLS to be within an acceptable margin of error," Secretary Newson continued. "This margin of error may be fine for Washington, but not here in Wisconsin. In order to address the serious needs of Wisconsin's workforce, our state needs an accurate jobs reporting system that allows us to understand the trends without unnecessarily alarming the state's job seekers and job creators."

Secretary Newson said Wisconsin is one of many states reviewing monthly estimate data to determine and recommend improvements to the methods that the BLS is using. For example, the state of Minnesota is experiencing similar fluctuations, including an initial estimate for July that was revised upward by 6,900 jobs.

"We understand the BLS is aware of the concerns that states are voicing, and we will continue to push for measures that result in less volatility for these numbers," Secretary Newson said.

#### **Place of Work Data**

The revised October numbers for Wisconsin show preliminary figures underestimated the state's total employment by 7,300 and underestimated private-sector employment by 7,900. The revised numbers for October show a net 2,400 total nonfarm loss and 1,400 for private sector loss, out of a total nonfarm employment base of 2.75 million jobs.

Preliminary November data indicates employment declines for the month in most categories. The data show that, compared to November 2010, the private sector gained 16,600 jobs, including 5,600 in manufacturing and 11,400 in educational and health services. The public sector lost 12,100 jobs over the year. Without seasonal adjustment, the estimates had similar results, a monthly private sector job loss, but a 15,600 gain over the year.

#### **Unemployment Rate**

Wisconsin's seasonally adjusted November unemployment rate was 7.3 percent, down from 7.7 percent in October 2011 and 7.6 percent in November 2010. Without seasonal adjustment, the November rate was 6.6 percent, down from 6.8 percent in October 2011 and 7.2 percent in November 2010. The rates encompass Wisconsinites who are available for work and actively seeking jobs and are generated by BLS from Wisconsin household surveys and other input.

The U.S. seasonally adjusted unemployment rate was 8.6 percent, down from 9.0 percent in October 2011 and down from 9.8 percent in November 2010. Without seasonal adjustment, the U.S. rate was 8.2 percent, down from 8.5 percent in October 2011 and down from 9.3 percent in November 2010.

Wisconsin unemployment rates remain below the national rates and, through October 2011, below rates of other manufacturing-heavy Midwest states including Illinois, Indiana, Michigan and Ohio.
